



PRIVATE MUSIC LESSON AGREEMENT – STUDENT, TEACHER, ARROWHEAD ARTS ASSOCIATION

This **Letter of Agreement** is between:

Arrowhead Arts Association (AAA), a California Nonprofit Public Benefit Corporation,

The Music Teacher (Teacher), _____,

The Music Student (Student) _____ Grade _____

The purpose of this Agreement is to set forth the terms and conditions under which AAA will pay Teacher for musical instruction provided to Student by Teacher.

Arrowhead Arts Association, Teacher and Student hereby agree as follows:

Subject to the terms and conditions of this Agreement, AAA agrees to pay fifty percent (50%) of the cost of the music lessons given to Student by Teacher up to a maximum cost of seven hundred and eighty dollars (\$780.00) for a series of lessons not to exceed fifty-two (52) lessons and for a period not to exceed fifty-two (52) weeks from the commencement date of this Agreement (see Notes and Agreement date below). Said payments shall be paid on a completed lesson period of thirteen (13) lessons based on a rate of 50% of the Teacher’s private lesson fee charged to Student by Teacher or \$22.50 per hour, whichever is less.

Notes:

- 1) If, for any reason, less than a total of 52 lessons are accumulated during the designated 52-week lesson period, submit the final report at the end of the 52-week period, regardless of the number of lessons listed on the report.*
- 2) This program is a maximum of 52 lessons, in 13-week segments, within a 52-week period from the Agreement date. No carryover of the 52 lessons beyond the designated 52-week lesson period is allowed.*
- 3) At the end of this one-year period, if Student has faithfully performed in accordance with the terms and conditions of this Agreement, Student may apply in writing to AAA for a one-year extension of this Agreement.*

Other Terms and Conditions of Agreement:

- 1) **Student** shall faithfully attend his/her scheduled music lessons and shall faithfully follow the lesson plan set forth by Teacher.
- 2) **Teacher** shall mail to AAA an attendance, charge, and progress report at the **end of each thirteen (13) lessons completed** by **Student**. If Student, in the opinion of Teacher and AAA, fails to maintain an acceptable attendance record and/or does not faithfully follow the lesson and practice plan set forth by Teacher, this Agreement may be terminated by AAA with a 1-week written notice to Teacher and Student.
